Tags Expired?

Since Spring, it has been difficult to get your updated tags for your vehicles so the Association has not tagged or towed any vehicles during this time.

Currently, the BMV offices are open and on-line are available also. Beginning November 10th, all vehicles must have current tags. We will be checking the property after that tagging vehicles and towing accordingly.

Don't Forget Your Parking Pass!

Over the past few months, vehicles have been towed because the parking permit was not being used.



Few reminders:

•Permits are required, except in authorized spots, every day from 10 PM to 6 AM. No notice is needed to have the



vehicle towed.

• If you park behind another person's garage, without permission, the owner has the right to have your vehicle towed immediately.

2021 HOA Dues Increase

Please make note that your HOA dues will increase to \$150.00, effective January 2021.

As always, payments must be received by the 15th of each month to avoid the \$25.00 late fee.

If you have your dues set up with auto pay with your banking institution, remember to update the payment information.

Assessment Deadline Fast Approaching

Thank you to all of you who have paid all or a portion of your assessment.

The deadline for all monies is December 31st.

To date, the Association has collected \$85,031.50. This leaves a remaining balance of \$34,968.50 still outstanding. Start making plans to finalize your account if you still owe for your assessment.

Bulk Item Pick Up

If you have bulk trash items that need to be picked up, you can call the City of Columbus at **3-1-1** and arrange for pick up.

<u>Do not put items outside until the night before your scheduled pick up.</u>

If items are left outside for more than 24 hours, we will have them removed by a private company.

You will be assessed a \$150.00 fine to cover the cost.
